



**Minutes of 2020 General Membership Meeting

1. Chair Barkley called the ZOOM meeting to Order at 2:22 PM

2. Action Items
  - A. Mary Pohlmann moved, Bruce Hopson seconded the approval of the Minutes of the March 30, 2019 General Membership Meeting. Motion approved unanimously.
  - B. Teresa McDowell moved, Larry Good seconded motion to accept the 2019 Financial Statement and 2020 Budget. The motion was approved unanimously by a voice vote.
3.
